The City of Gallatin Police Department seeks to purchase 15 or more sets of Level IIIA Body Armor from a qualified vendor.

2.0 Vendor Requirement

- On-Site fitting within 48 hours of notification.
- On-Site fitting within 48 hours of notification of any misfits.
- Vendor to return any misfit armor.
- Price to includes all shipping.
- Price Good for ONE (1) year after bid acceptance.

3.0 Evaluation of Proposals

The City of Gallatin will award the contract to lowest responsible and responsive bidder meeting specifications, quality, and performance standards pursuant to the Municipal Purchasing Act of 1983. Response will be based on the following factors;

- V50 .44mag 1580 fps
- Certification Backface - .357 sig 27mm
- Certification Backface - .44 mag 36mm
- 5 X 8 Hard Impact Plate.
- 5 X 8 Soft Trauma Plate.
